- 4. The voting rights of Shareholders shall be in proportion to their shares of the paid up equity share capital of the Company as on the cut-off date i.e., August 3, 2018.
- 5. The date of determination of shareholders for dispatch of notice is June 22, 2018.
- 6. Since the Company is required to provide members facility to exercise their right to vote by electronic means, shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of August 3, 2018 and not casting their vote electronically, may only cast their vote at the 74<sup>th</sup> Annual General Meeting.
- 7. Mr. Parminder Singh Rally, Practicing Company Secretary (Membership No. 6861) has been appointed as the Scrutinizer to scrutinize the e-voting process in a fair and transparent manner.
- 8. The Scrutinizer shall within a period of not exceeding three (3) working days from the conclusion of the Annual General Meeting, unlock the votes in the presence of at least two (2) witnesses not in the employment of the Company and make a Scrutinizer's Report of the votes cast in favour or against, if any, forthwith to the Chairman of the Company.
- 9. The Results shall be declared within 3 days from the 74<sup>th</sup> Annual General Meeting of the Company. The Results declared along with the Scrutinizer's Report shall be placed on the Company's website www.sukhjitgroup.com and on the website of NSDL within three (3) days of passing of the resolutions at the 74<sup>th</sup> Annual General Meeting of the Company on August 8, 2018 and as communicated to BSE Ltd.
